### RESULT OF THE SALE BY TENDER OF UP TO £1000 MILLION OF 0¼% TREASURY GILT 2028

The United Kingdom Debt Management Office ("DMO") announces that the tender of up to £1,000 million of 0¼% Treasury Gilt 2028 (ISIN Code: GB00BMBL1G81) has been allocated as follows:

- All bids which have been accepted at the lowest accepted price have been allotted 20.0000% of the amount bid for.

Competitive bids made at prices above the lowest accepted price have been allotted in full. Competitive bids made at prices below the lowest accepted price have been rejected.
