RESULT OF THE SALE BY AUCTION OF £2750 MILLION OF 11/4% TREASURY GILT 2027

The United Kingdom Debt Management Office ("DMO") announces that the auction of £2,750 million of 11/4% Treasury Gilt 2027 (ISIN Code: GB00BDRHNP05) has been allocated as follows:

1. All bids which have been accepted at the lowest accepted price have been allotted 4.5816% of the amount bid for.

Competitive bids made at prices above the lowest accepted price have been allotted in full. Competitive bids made at prices below the lowest accepted price have been rejected.
