RESULT OF THE SALE BY AUCTION OF £3750 MILLION OF 33/4% TREASURY GILT 2027

The United Kingdom Debt Management Office ("DMO") announces that the auction of £3,750 million of 3¾% Treasury Gilt 2027 (ISIN Code: GB00BPSNB460) has been allocated as follows:
