## RESULT OF THE SALE BY AUCTION OF £2750 MILLION OF 33/4% TREASURY GILT 2053

The United Kingdom Debt Management Office ("DMO") announces that the auction of £2,750 million of 3¾% Treasury Gilt 2053 (ISIN Code: GB00BPCJD997) has been allocated as follows:
