RESULT OF THE SALE BY AUCTION OF £3750 MILLION OF 4% TREASURY GILT 2031

The United Kingdom Debt Management Office ("DMO") announces that the auction of £3,750 million of 4% Treasury Gilt 2031 (ISIN Code: GB00BPSNBF73) has been allocated as follows:

1. All bids which have been accepted at the lowest accepted price have been allotted 64.5000% of the amount bid for.
