The United Kingdom Debt Management Office ("DMO") announces that the auction of £2,250 million of 41/4% Treasury Stock 2036 has been allocated as follows:

 All bids which have been accepted at the lowest accepted price have been allotted approximately 41.5% of the amount bid for.
