Re-scheduling of the auction of 01/4% Treasury Gilt 2025

Following confirmation from the Chancellor that the Autumn Statement will be delivered on Thursday 17 November 2022, the UK Debt Management Office (DMO) is announcing that the auction of 0¼% Treasury Gilt 2025, previously scheduled for Wednesday 16 November 2022, will now take place on Wednesday 23 November 2022. The auction size and further details will be announced on Wednesday 16 November 2022 at 3.30pm.

Any update to the DMO's financing remit for 2022-23 will also be announced alongside the Office for Budget Responsibility's (OBR's) Economic and Fiscal Outlook (EFO) on Thursday 17 November 2022.
