RESULT OF THE SALE BY AUCTION OF £4,750 MILLION OF 4¼% TREASURY GILT 2011

The United Kingdom Debt Management Office ("DMO") announces that the auction of £4,750 million of 4¼% Treasury Gilt 2011 has been allotted in full.

(Note: all prices in this notice are quoted in pounds and pence)

1. All bids which have been accepted at the lowest accepted price have been allotted approximately 59.0% of the amount bid for.

Competitive bids made at prices above the lowest accepted price have been allotted in full.
Competitive bids made at prices below the lowest accepted price have been rejected.
