- Wednesday 6 April 2011: 11/8% Index-linked Treasury Gilt 2037

The nominal sizes, and other terms of the auctions, will be announced by the DMO at 3.30pm on Tuesday 29 March 2011.

The gilts to be auctioned at the remaining auctions in April-June 2011 will be announced by the DMO at 3.30pm on Thursday 31 March 2011.

## NOTES FOR EDITORS

The DMO remit for 2011-12 was published alongside Budget 2011 on 23 March 2011. Gilt sales of £169.0 billion are planned in 2011-12, split by maturity/type and method of issue as shown in the table below.
