STERLING TREASURY BILL TENDERS: APRIL TO JUNE 2003

In the first quarter of the 2003-04 financial year the DMO will hold a weekly tender at which the Treasury bills on offer are likely to comprise both one-month (approximately 28 days) and three-month (approximately 91 days) bills. In addition, the DMO intends to continue issuing six-month bills (approximately 182 days). These are currently issued on a monthly basis, but the DMO may choose to start issuing them more frequently during the quarter.

The precise quantities and maturities of sterling Treasury bills on offer will be announced with the results of the tender in the week prior to the relevant tender. The DMO expects the nominal amounts of three and six-month bills on offer at each tender to be relatively stable. The tender and settlement dates for the tenders to be held in the April to June 2003 period are set out below.

The next quarterly notice outlining the likely nominal amounts on offer and maturities of sterling Treasury bills to be made available at tenders in the period from July to September 2003 will be issued with the results of the tender to be held on 27 June 2003.

NOTE TO EDITORS

The DMO publishes each quarter a timetable for Treasury bill tenders for the quarter ahead, and an indication of likely maturities. The provisional DMO remit for 2003-04 was published on 20 March 2003, and assumes that the outstanding stock of Treasury bills will be increased by £3.2bn to £18.2bn. The provisional remit was based on HM Treasury's projections for the CGNCR as published in the Pre-Budget Report on 27 November 2002. New forecasts for the CGNCR will be included in the Budget on 9 April 2003 and the remit will be restated and revised as necessary on that date.
