RESULT OF THE SALE BY AUCTION OF £1750 MILLION OF 13/4% TREASURY GILT 2037

The United Kingdom Debt Management Office ("DMO") announces that the auction of £1,750 million of 1¾% Treasury Gilt 2037 (ISIN Code: GB00BZB26Y51) has been allocated as follows:

1. All bids which have been accepted at the lowest accepted price have been allotted 82.9860% of the amount bid for.

Competitive bids made at prices above the lowest accepted price have been allotted in full. Competitive bids made at prices below the lowest accepted price have been rejected.
