RESULT OF THE SALE BY AUCTION OF £2500 MILLION OF 1% TREASURY GILT 2032

The United Kingdom Debt Management Office ("DMO") announces that the auction of £2,500 million of 1% Treasury Gilt 2032 (ISIN Code: GB00BM8Z2T38) has been allocated as follows:

1. All bids which have been accepted at the lowest accepted price have been allotted 55.2631% of the amount bid for.

Competitive bids made at prices above the lowest accepted price have been allotted in full. Competitive bids made at prices below the lowest accepted price have been rejected.
