This issue of the Stock will rank for the payment of the non-standard first coupon on 7 September 2011.

Application has been made to the UK Listing Authority for the Stock to be admitted to the Official List on 6 July 2011.

Application has also been made to the London Stock Exchange for the Stock to be admitted to trading on the London Stock Exchange's regulated market.
