RESULT OF THE SALE BY AUCTION OF £4000 MILLION OF 3¾% TREASURY GILT 2027

The United Kingdom Debt Management Office ("DMO") announces that the auction of £4,000 million of 3¾% Treasury Gilt 2027 (ISIN Code: GB00BPSNB460) has been allocated as follows:

1. All bids which have been accepted at the lowest accepted price have been allotted 21.7346% of the amount bid for.
