

## USE OF THE DMO'S STANDING REPO FACILITY - 17 FEBRUARY 2011

In accordance with the terms of the DMO Standing and Special Repo Facilities, effective from 6 August 2009, the DMO has today borrowed additional stock made available by the Bank of England for Standing and Special Repo purposes, using holdings acquired under its Asset Purchase Facility (APF). The DMO has been given general collateral at the Bank of England's Official Bank Rate against the stock it has lent at 0.10% for the standing repo.
