The United Kingdom Debt Management Office ("DMO") announces that the auction of £1,750 million of 4¾% Treasury Gilt 2043 (ISIN Code: GB00BPJJKP77) has been allocated as follows:

1. All bids which have been accepted at the lowest accepted price have been allotted 26.0000% of the amount bid for.
